Nevada. If you have this, please provide your PR# You must then complete a Risk Assessment
Packet for each of the markets that you wish to sell your products. It must be completed and returned to the
market manager with a \$30.00 fee per market at least three (3) weeks prior to the opening day of the market. For
any Risk Assessment Forms turned in after opening day, the fee is \$50.00 per market and the approval time is in
the hands of the Environmental Health Dept. These fees are required by the Environmental Health Department.
The market manager will turn this into Environmental Health on your behalf and they will add you to our market
certificate and update the manager upon your approval to sell at one or more of our markets.
